Horrific mass casualty events are happening too often and are impacting our nation indiscriminately. Americans want a solution – we've found one.

For decades, the process of Behavioral Threat Assessment and Management (BTAM) has been used successfully to identify, investigate, assess, and mitigate threats to counter targeted violence. Pioneered by the Secret Service, BTAM helps to determine the credibility of a threat and interrupt those on a pathway to violence. **Even the Capitol Police has its own BTAM unit to protect Members and staff and has been doing so since 1986.** If this evidence-based process works to protect our presidents, foreign dignitaries, celebrities, and us, **why aren't we using it to protect our schools and communities?**

"Let's manage the threat before an attack occurs because by the time the first shot has fired, it is too late – we have failed." – Rep. Babin

The reality is that no reactive method is fast enough to stop the first shot from being fired. It is imperative that we manage threats before an attack can occur. **The TAPS Act will:**

- Provide guidelines and best practices across the Federal Government and down to the state and local levels;
- Provide states and local entities the training, resources, and support needed to stand up community-based, multidisciplinary behavioral threat assessment and management units; and
- Establish a temporary working group made up of experts in BTAM to make recommendations to Congress for a National Strategy for preventing targeted violence.
